



# **Have Your Horsey Birthday Party @ Serendipity Farm**

*Thank you for your interest in having your birthday party at our farm. We offer an equestrian atmosphere by our very own 2 stall, birthday barn. Have your birthday party at a premier equestrian facility and learn horsemanship!*

**3 Hr Cowpony Package:** This western themed package offers a short, hand led, riding lesson for each child. Children will learn horse safety and how to control the horse or pony while riding. Horses will be brought out for 1 hour at the beginning of your party. The second hour is for your party.

1-5 children \$200.00 (one or two horses will be used)

6-10 children \$400.00 (three or four horses will be used)

11 or more children add \$15.00 per child

Birthday child rides for FREE.

A note about the horses and ponies, we do not give just a “pony ride” we give a safely led, group lesson that ends with a tour around our facility on horseback. To top that off, we toss some apples in a bucket and the horses get to “bob” for apples at the end of each ride with children still aboard! Riders will be in the saddle for 10 minutes. Party goers will learn horse safety and will also learn the basic control of the horse or pony that they are riding by a certified riding instructor. Our fun coordinator will play Rodeo games with children who are waiting to ride. Barrel Racing and Roping. We also have a small playground next to the party location that children can play on.

To reserve your space, we require **\$100.00** non refundable deposit.

We provide 2 picnic tables. We will have additional plastic chairs for guests. If you require more chairs you must provide those. We have an indoor air conditioned bathroom and plenty of trash cans. We will handle garbage removal. We do have a full service birthday party options where we handle the cake & ice cream (horsey of course), pizza and western table decorations. This option includes a craft, activity and face painting.

Upon your request we can offer additional services for a fee such as painting and decorating real used horseshoes, face painting, treasure hunts, small animal petting zoo and finger painting of an actual horse or pony.

## Rules for the Party:

Horses are a prey animal, which means they get scared very easily. When horses are scared they become unpredictable and their behavior can change from quiet sweet horse to bolting bucking and kicking. Knowing this we try to clear the area of possible spooky objects.

Balloons are not allowed near the tables where the horses will be. You may hang balloons by the entrance of the property and on the fence by the drive way. Noisy party favors should be passed out once the horses leave the area.

All Guests need to have a Serendipity Farm Liability Release form signed by a parent or guardian if under 18. See Attached. Parents should supervise children at all times while on playground and around pond.

Tell your guests to wear sensible shoes like sneakers or boots.

Children should not be allowed to run up to any horse.

You may tour the barns but please do not touch any of the horses or ponies. Like dogs, not all horses are friendly. No feeding the horses or ponies in the barns or paddocks, not even hand picked grass. You will get plenty of equine interaction with the pony party horses.

The pony party horses can have carrots and apples as treats if you feel inclined to bring them we will show you how to safely feed them.

All riders must wear a ATSM Certified Riding Helmet provided by the riding instructor. Our helmets are sanitized after every use.

Children must be 2 years old before riding the pony. Children should be able to hold on to the saddle horn and sit up by themselves. Sometimes children require mom or dad to walk beside them with the pony so wear sensible shoes. Most parents want to hold the child at the waist but sometimes end up pulling them off balance. Sometimes it's hard to keep up with a 4 legged animal. It's better to hold your child's hand or leg by the thigh (we will show you how).

No riding double.

Hand Sanitizer is provided.

No camp fires and no smoking.

No dogs allowed.

RELEASE AND INDEMINITY AGREEMENT

I/We hereby indemnify and agree by this signing, to release Property maintenance Services, Inc dba SERENDIPITY FARM Scott McPherson, Sandra Ferrera, and Alisha Laird, all associated persons for any accident or injuries sustained by me, my employees, heirs, representatives, dependents, or guests. It is understood that wherever the words "stable/owners" are used in this agreement, it includes landowners, stable owners, trainers, riding instructors, independent contractors, employees, parents and any other individual, but not limited to the following named individuals: SERENDIPITY FARM, Scott McPherson, Sandra Ferrera, and Alisha Laird. For today and all future use of the property and the facilities and services offered.

As an owner, student, contestant, spectator, employee, independent contractor, or parent, I/We the undersigned recognize that all equestrian related activities are extremely dangerous, and that accidents involving horses are frequent. That the propensity of equines to behave in ways such as running, bucking, biting, kicking, shying, stumbling, rearing, falling, stepping on, that may result in an injury, harm, or death to persons on or around them. The equine's reaction to such things as sounds, sudden movements and unfamiliar objects, persons or other animals is unpredictable. The potential of a participant to act in a negligent manner that may also contribute to an injury, such as failing to maintain control over the animal or not acting within a participant's ability. That the condition of the land is often hazardous, and the ring footing is rarely perfect. In light of the knowledge, I/We undertake full responsibility for all harm that comes to me/guests and my/our stock and all of my/our associates. With full knowledge, I/we release the hereinafter-named stable/owner from all responsibility for accidents and injuries.

**WARNING: Under Florida Law Statute 773.01-773.05 an equine activity sponsor or equine professional is not liable for the injury to, or death of, a participant in an equine activity resulting from the inherent risks of equine activities.**

The signing of this release implies that I/We have adequate medical and liability insurance/protection and that the Stable/Owner will assume no responsibility for horse or rider. Losses occasioned by the injury or death of rider, spectator, or horse is agreed to be covered by the insurance of the undersigned. It is further agreed that the undersigned's heirs, representatives, dependents or guests shall have no right or action against the Stable/owner, employees, independent contractors, or any of their insurance carriers.

If the person who is the primary user of Serendipity Farm facilities is less than eighteen years old, the signature of this agreement must be executed by the parent(s) and the release of liability of the Stable/Owners, **RIDER OR RIDER'S PARENT OR GUARDIAN AGREES TO HOLD HARMLESS, INDEMNIFY AND DEFEND MANAGER AGAINST ANY AND ALL CLAIMS, DEMAND, CAUSES OF ACTION, DAMAGES, JUDGEMENTS, ORDERS, COST OR EXPENSES, INCLUDING ATTORNEY'S FEES, WHICH MAY IN ANY WAY ARISE FROM OR BE IN ANY WAY CONNECTED WITH RIDERS USE OF OR PRESENCE UPON THE PROPERTY OF SERENDIPITY FARM, AND OR THE USE OF ITS FACILITIES.**

If damage is caused by or to the undersigned's horse(s) including, but not limited to, escape from the enclosures, the undersigned takes full responsibility for damages to person, property, or other horses and agrees to indemnify the STABLE/OWNERS against liability for such damages.

The undersigned further agrees to indemnify the STABLE/OWNERS against any liability for physical loss or injury, or damage causing death or the necessary destruction of horse or horses in the STABLE/OWNER care.
